We will only disclose the information provided by PGG to the Client and will not, directly or indirectly, disclose or permit anyone else to disclose this information to any firm or entity without the prior written consent of PGG. We will not use or permit the information to be used in any manner detrimental to the interest of the vendor or PGG or their affiliates.
4. We acknowledge that we must sign a separate copy of this agreement for each Client.
5. This co-operating brokerage form is only valid when accepted by Pierre Gagné, Broker of Record.
6. This Agreement will expire May 15<sup>th</sup>, 2009.
